## "T.O.S.A. DIARY"

November 30th, Wednesday, 8.00p.m.

Don't forget the Annual General Meeting on this night in the Marrickville Town Hall.

Annual Election of Executive and Committee:

The nomination and election of Executive and Committee at present being conducted has been declared null and void for the following reasons:

- a) There is no provision in the by-laws for conducting a postal ballot.
- b) Due to some members pominating for more than one position many voters would not be able to exercise their full voting rights. This is because if a member is elected as a member of the executive then any votes cast for that member in any other position would not be counted and so the voter would not have been able to cast his full quota of valid votes.
- c) Due to the closing of nominations being moved from October 15th to September 15th the by-law has been breached and so the nominations are invalid. (Section 16a states "Nominations to close six weeks before the Annual Meeting).

The Executive and Committee apologise for any inconvenience to those who may have already voted.

Other business to be discussed.

- 1. The Executive and Committee exercising it's authority under by-law 25 proposes an additional by-law, to be known as 16c, to allow postal voting to financial members, such vote to be received as stipulated on the ballot paper.
- 2. Members will be asked to consider and decide on
  - a) the desirability of a candidate nominating for more than one position
  - b) if multiple nomination is accepted, then your preference for separate officers to be indicated.
- 3. Notice of Motion, as publicised in August issue of T.O.S.A. News, That by-law 26, paragraph 2 be amended as from the words 'extraordinary meeting' to read -

The decision to wind up the activities and affairs of the Society can only be made by at least two thirds (2/3) of the members present and entitled to vote at such an Extraordinary Meeting. In the event of a decision to wind up the Society all monies property and organs excluding the ex Prince Edward Organ be sold and such monies be divided among members remaining in the Society at that date. The ex Prince Edward Organ be handed over to the Municipality where it is installed for use by residents of that Municipality 4. Notice of Motion, as publicised in the September issue of T.O.S.A. News,

That by-law No. 9 be amended to read (from the beginning)

The Executive of the Society shall consist of President, Secretary,
Treasurer and Two Vice-Presidents and these shall have full voting powers
with the exception of the President who shall only have a casting vote. The
remainder of the by-law from the paragraph "The Executive, subject to any
directions" etc. will remain unaltered.
