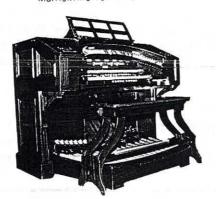

### PROFILE OF MARGARET HALL

Born in Sydney in 1963, Margaret Hall began learning popular organ at the age of nine. After three years, she moved on to classical organ and piano In 1984, Margaret undertook studies. full time study at the NSW State Conservatorium, majoring in Four years later, she performance. graduated as a Bachelor of Music with Merit'.

At fourteen, Margaret began a four year residency as organist for Mecca Theatres in Sydney. At the Kogarah Mecca she presided over a three manual eight rank WurliTzer, gaining valuable experience in theatre organ presentation whilst developing her own style.

Since 1977, Margaret has performed on numerous occasions for the Theatre Organ Society of Australia (NSW Div.) She has been featured at three National Conventions and was also one of the five artists invited to re-open the ex-Sydney Capitol WurliTzer in the Orion Centre, Campsie, in October, 1988.

Margaret is increasingly in demand for concerts around Australia in New Zealand. She made her United States concert debut in July, 1991, when she performed for the Puget Sound Chapter of the American Theatre Organ Society.

A Margaret Hall Concert is full of variety, covering music from the popular classics to contemporary hits. sensitive. appropriately Her combined approach, congenial professional stage presence has justly earned her the title of "Australia's First Lady of Theatre Organ".

Released in May 1992, Margaret's first commercial recording entitled " KITTEN includes some of her ON THE KEYS" most popular concert material will be available at her forthcoming programme.

I am the sole U.K. importer of spares for Conn, Kimball, WurliTzer, Baldwin, Gulbransen and also import spares for Rogers, Lowrey, Fender-Sunn, Acetone, Thomas and most other makes." As I have not been able to obtain technical specifications or help without considerable expense(as I live in the country) regarding a Gulbransen Premier theatre console organ, I wrote to Alan Morrison. I am sure our members with organs would find this of considerable interest. Other State divisions of TOSA would no doubt also find this of interest. Keep up the good work with TOSA News.

By the way, I do believe that one of the big contributing factors to the drop in interest in organ concerts, is because of the demise of all those wonderful "Electronic Home Organs". ### ☆ THE TOSA CHARITY CONCERT 卆

### Sunday, 30 August, 1992

### REVIEWED BY COLIN TRINGHAM

After a brief introduction by compere Tony Ward, the Mayor of Canterbury Council and co-Patron of T.O.S.A. John Gorrie, welcomed everyone to the Charity Concert. One note which disconcerted a few was that the Yellow Rolls Royce Orchestra had gone to the Cremorne Orpheum originally by mistake.

Undaunted, Neil Jensen commenced the concert by raising the Console in fine style with a toe-tapping Cole Porter selection, featuring Blow Gabriel Blow, It's Delovely, My Heart Belongs to Daddy and I've Got You Under My The frequent tonal changes were an object lesson to anyone thinking that a tune should be played with just one stop setting from beginning to end. Neil achieved a thoroughly 'Orchestral' sound from the 3/17 Wurlitzer. more show stoppers followed, Stairway the Stars and a breathtaking Slaughter on Tenth Avenue, expertly played by Neil.

The console descended to rise again to 'accompaniment level' as John Giacchi played for the singing as members of the Canterbury Theatre Guild performed hits from past shows. Artists included Colin Peat and the youngest member of the group with two songs from Annie and a Sound of Music selection.

John Giacchi raised the console to 'stage level' to play a bracket of numbers from the Gold Diggers series of shows, including a memorable version of We're In The Money. John's playing has certainly matured since I last heard him and he seemed very much at home at the Console, coaxing new and interesting sounds out of the pipes and percussions, with every phrase.

Neil returned to the Console while the Yellow Rolls Royce Orchestra held the stage to end the first part of the programme with a series of toe-tapping melodies, including, El Choclo, Ramona, and Boo-Hoo. The Organ and Orchestra members combined wonderfully, although from where I was sitting, the Piano and Double Bass needed some re-inforcement with a microphone or two. I understand this was not a problem closer to the stage.

The stylish singing of the Bandleader, Phillip Sametz and his energetic antics also kept us entertained.

A short Interval followed and the door-takings were tabulated. A cheque for \$4,800. was presented to Elaine Smith, a representative of St. Vincent's Hospital during the second half of the show - a really worthwhile effort.

Neil raised the console again to play a reprise of It's Delovely, Sentimental Journey, An Earful of Music and as an encore, Brown Eyes Why Are You Blue.

Next, Helen Zerefos appeared in an incredible pink gown, featuring yards (if not miles) of pink ruffles. With sparkling jewels in her hair and a multicoloured jewelled bodice, she looked every inch the professional entertainer. There was some humourous 'chit-chat' between Helen and Neil and they are obviously both at ease in each other's company. After a selection of the appropriate Microphone, sang a selection from the Phantom of the Opera with a particularly memorable Music of the Night. Helen concluded by singing from her operatic repertoire - Sempre Libre Throughout her perform-La Traviata. ance we were treated to a voice which was pure and accurate and extremely enjoyable.

Once again the Canterbury Theatre Guild Members took the stage, accompanied by John Giacchi, to sing numbers from their forthcoming production of the musical Nine. The show features singing which was more reminiscent of Operatic Recitative than melodies which one could whistle, but it was very well done and John played the accompaniment on the Organ in a very competant manner, despite some difficult-sounding harmonies. This should be a show worth seeing.

The Yellow Rolls Royce Band returned to play two numbers as a finale, these were a bright and bouncy She's a Latin from Manhattan and a bold and brassy Bei Mir Bist du Sein. I could see feet moving and heads nodding all around me in time to the snappy rhythm.

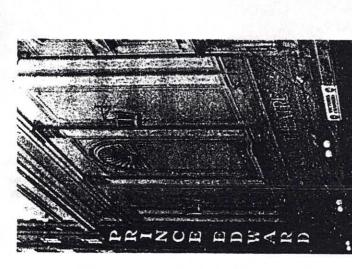
The concert was a great success and all associated with it, the back-scene people and the artists who so generously donated their time, are to be thoroughly congratulated and thanked.



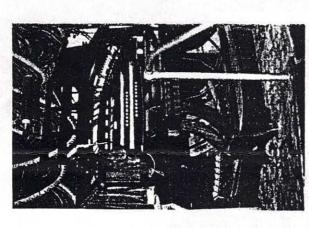

MISS NOREEN HENNESSY, resident theatre organist at the Prince Edward Theatre from 1945 to 1965, and an Honorary Member of the Theatre Organ Society of Australia.

The Prince Edward Wurlitzer organ and Miss Noreen Hennessy have formed an attractive combination to lovers of theatre organ music over 20 years. Many patrons attended the theatre regularly just to hear this combination.

Miss Hennessy has always taken a great interest in the Theatre Organ Society and is held in the highest regard by its members.

The chance that the organ might be broken up for parts when it was known that the theatre was destined for demolition, led members of the Society to endeavour to save the organ if they could, and within one week they raised among themselves the necessary finance to purchase the organ.

Although this final recital is a somewhat sad occasion, negotiations are well under way to re-install the organ in the fine Town Hall at Marrickville, where it may continue to be heard to best advantage by the public.

Miss Noreen Hennessy is certain to be one of the first organists to be featured at the organ in its new location.

The Theatre Organ Society of Australia, acknowledges with gratitude the courtesy and cooperation of the management of the Prince Edward Theatre which has made this recital possible.

### Your T.O.S.A. Concert

So you read about this Artist and Concert in your T.O.S.A. News magazine. Glad you came to lend support to the efforts of your Executive and Committee to provide quality entertainment for all members and their families. The show will start in a few minutes time, so just sit back and relax.....By the way, have you ever given any thought to the amount of time, effort, planning and personal input that has gone into the presentation of this afternoon's entertainment just for you?

Before any planning can commence, a list of available dates must be obtained from both the Marrickville and Canterbury Municipal Councils.

A special Planning Meeting is arranged and following discussion, a list of acceptable dates and locations is prepared. The artists to perform for the Society in the coming year are then nominated and selected.

As soon as the concert calendar has been completed, the Artist Liaison Officer is instructed to contact each artist and invite that person to perform 'In Concert' on one of our two WurliTzer Theatre Pipe Organs. Once the artist has indicated willingness to play on the planned date, all necessary arrangements are finalised.

Now the preparation for this particular concert can be moved into "TOP GEAR" and all areas of preparation begin to operate efficiently to bring you a trouble free afternoon of entertainment.

The Editor of T.O.S.A. News is advised and advertising is planned, prepared and finally in the Society's magazine.

The Ticket Secretary is informed, arrangements made for the concert date tickets to be printed and a seat booking plan is prepared months in advance to accommodate advance bookings. These bookings will be progressively monitered to keep the Executive informed of the anticipated attendance totals so that other areas of preparation can be implemented as required.

The Publicity Officer will prepare advertising material and at the appropriate time forward this information to the various media outlets, e.g. Local Newspapers, Radio Stations, T.O.S.A. Printer for advertising pamphlets etc., and through our Theatre Organ Highlights radio programme for special announcements.

Depending on the concert location, either the Society's or Council Signwriter will prepare a static advertising display and fix it in

position outside the hall prior to the concert date.

Where security is provided by the Society for members' cars, the Security Service must be advised so that sufficient Security Officers are provided on concert day. (Requirements are based on anticipated attendance).

The Candy Bars and Tea and Coffee Stand must be stocked to provide sufficient supplies to meet customer requirements. (Based on anticipated attendance).

The Record Bar stock is checked and supplemented as required, to provide a broad selection of Audio Tapes, Compact Discs, and Video Tapes for those who collect all forms of Theatre Organ music. This shop also provides a small quantity of special books on the Theatre World.

As the concert date draws closer, arrangements are made for our concert artist to be provided with practice time to become familiar with the instrument to be played and to fine tune the concert performance.

Usually a few days before the concert, the Theatre Pipe Organ has its final maintenance completed and is then tuned.

On concert day, a small band of dedicated T.O.S.A. members arrive at the hall early in the morning and set about preparing the various areas required for the overall concert presentation, e.g. Ticket Office, Candy Barm Tea and Coffee Stand, Record Bar and Tape Library, Book Library and TOSA News stand. etc.

If it is anticipated that additional seating will be required, additional chairs would have been previously ordered and are delivered on the day of the concert.

The Concert Recording Technician will be busy running out the Audio leads and setting up the general recording equipment. When this has been done, final testing will be made to ensure that all is in perfect working order to record the concert.

The Organ Maintenance staff prepare the Theatre organ for the performance and one last practice session is run through by the artist.

At last it's approaching concert time. The ticket sellers are in their ticket box, the Ushers are in position at the doors, the audience is beginning to fill the hall.

From the stage a voice comes loud and clear over the Public address system - "GOOD AFTERNOON LADIES AND GENTLEMEN" - the concert is about to begin .....

Enjoy your concert and spare a thought for all those TOSA people who helped put this concert together for you and your friends enjoyment.

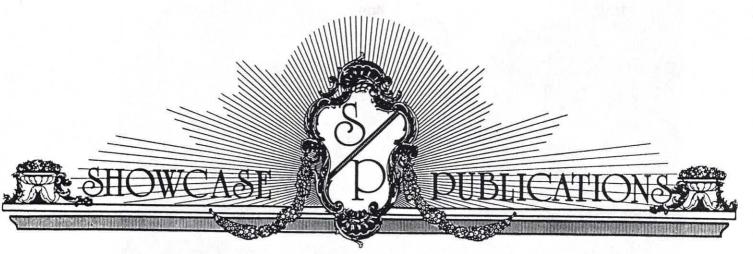
### TONY FENELON OFF TO THE U.K.

### Dear Book Buyer:

We are pleased to make a very special announcement regarding the series, "Encyclopedia of the American Theatre Organ". So far you have seen completion of volumes one and two, written and financed by David L. Junchen. As many of you probably know, the author passed away in January of 1992.

Showcase handled production and distribution on the first two books and was in the process of assembling volume three at the time of Junchen's death. The rights to the first two books and unfinished third one, dealing with the Wurlitzer company, have been bequeathed to Showcase. However, to complicate matters, Junchen was indebted to us for over \$23,000, monies the estate may not be able to pay. He had also underwritten the first two books at a substantial personal loss. Because of the present circumstances and limited sales potential, we are not able to underwrite publication costs ourselves.

There has been a great deal of interest expressed in seeing the final book completed. We have been faced with several other problems related to determining the best way in which to publish the Wurlitzer story. No one really knew just how ill the author was for several years while he attempted to complete research and writing for the final volume. Owing to his illness, we believe Junchen prematurely stopped most research, and instead worked as his health permitted, to finish it using materials already on hand, hoping he might see it published in his lifetime. Subsequently, during a complete analysis of the manuscript by a group of organ historians, numerous gaps in the research became obvious. As a result, Preston Kaufmann took the project on as co-author. It has been his goal to undertake a thorough search that would insure all possible sources of historical items are fully taped, which will make the Wurlitzer story as complete as possible.

It has been difficult to finalize a concept for publication of volume three; with just the material collected by Junchen, the number of pages would have been over 800. Adding photos, drawings, advertisements and other historic information since located, the count has grown to

over 1,100 pages. Splitting this into two volumes would have necessitated a price of over \$125 apiece. With reluctance, we have taken out the master opus list of all manufactures combined that Junchen spent a great amount of time compiling; this helped in cutting costs. It has been decided to issue the Wurlitzer story in three volumes of approximately 300 pages each.

Following is an explanation of how the first two books and remaining three on Wurlitzer will be made available:

VOLUME 1: This book has been out of stock for some time, although there has been limited call for copies. We will be able to have a small press run produced, if enough buyers will subscribe or underwrite its printing. Pricing is based on current demand numbering under 100 copies; for this reason, the price is higher than normal.

VOLUME 2: Still in stock, this part of the series can be ordered for immediate receipt.

VOLUMES 3, 4, 5: These will cover the Wurlitzer company and its theatre organs. Because Junchen underwrote the first two volumes, and due to the series' very limited appeal, we must now ask interested readers to help finance publication. This is being handled on a subscription basis, with one volume being produced at a time. The expense of publishing these books is costly and direct reader support is the only way we believe to insure their publication. In each book, we will publish a list of those subscribing to that particular volume. Further details about this may be found on the order form. If too few subscriptions are received in the time frame allowed, that would permit completion of volume 3, customer monies will be returned and the Wurlitzer portion of the project will remain unpublished.

For those interested in seeing the Master Opus List of theatre organs published, please indicate your desire to purchase a copy on the backside of the order form. This list is a compilation of all manufacturers totaling over 7,000 instruments, assembled on a geographical basis, and would be approximately 225 pages in typeset form. If enough demand is demonstrated, it can be printed and bound in the same format as the other books in the "Encyclopedia" series.

An informative flyer describing the series and order form accompany this letter. We sincerely hope for your support in this very important contribution to the history of the theatre organ.

Perhaps America's premiere musical instrument company for over 100 years, the Rudolph Wurlitzer Company was the most prolific manufacturer of theatre pipe organs. It is a company with a rich and colorful history, from its personalities, achievements and fame. Initial research and writing for these volumes was assembled by the late David Junchen; with further fact finding, location of more illustrations and other additions, it is being completed by Preston Kaufmann, author of "Fox-The Last Word . . . . story of the world's finest theatre".

Emergence of the Wurlitzer family as leaders of the musical instrument field is covered during the early years of growth through 1909. Next the story of Robert Hope-Jones, first in England, and then America, is brought to life; included of course is his association and effect upon Wurlitzer and unit organs.

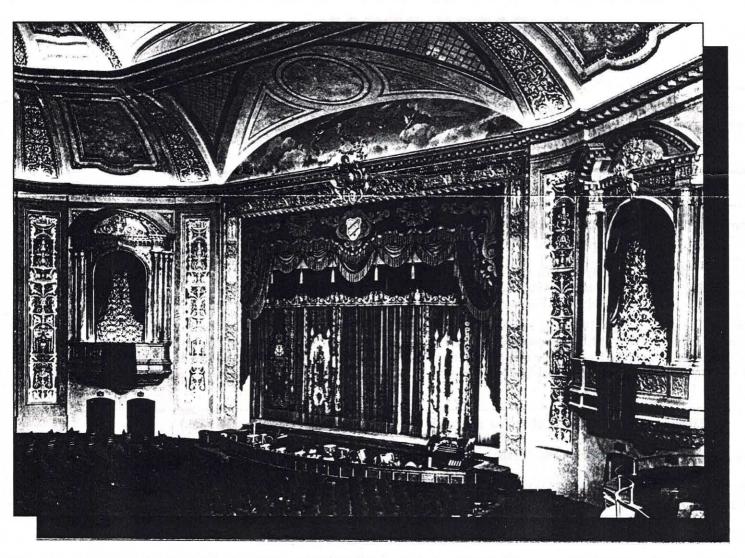
With an established firm, it was not surprising that the company embarked upon a campaign selling products to theatres . . . . organs, photoplayers, pianos and orchestrions. Output for much of these instruments took place in the vast factory located at North Tonawanda, New York. Its history and development is thoroughly covered in text and illustration.

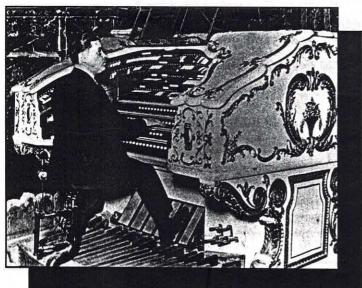
General coverage is devoted to photoplayers and theatre organs, where details on sales/production, stock models and advertising samples, are reproduced. Technical information on organs, including stock style specifications, shipments by style, wiring schedules and part numbers, bring together much fascinating data.

Surveying major time frames in unit organ development, growth and decline . . . . 1910-1919, 1920-1926 and 1927-1932, permits a tour of several hundred theatres with Wurlitzer organs, illustrated with consoles, chambers, auditorium views and trade advertisements. Installations in overseas locales, residences and churches, are also extensively covered, both pictorially and through informative text. Another section covers the firm during the period 1933-1990. As demand for theatre organs diminished, new products were introduced to keep Wurlitzer profitable. And to conclude, there is both a geographical and chronological opus list of the entire known unit organ output by Wurlitzer, 1910-1943.
